Troop 32 plans to participate in the Longhorn Council's Chisholm Trail High Adventure Base summer camp at Sid Richardson Scout Ranch. This camp is a unique and unforgettable high adventure for older youth and adults. Although a backpacking program, pontoon boats are used instead of boots to travel between high adventure and water sports bases on 19 miles of Lake Bridgeport shoreline! You'll see rugged and beautiful parts of our camp that troops rarely see!

At Chisholm Trail you spend the morning and evenings at a high adventure outpost, and every afternoon at a water sports base. High adventure posts include U.S. Cavalry, Texas Rangers, Comanche Village, Climbing, Covert Ops, Sporting Clays, Sport Orienteering, Texas Cowboy Cooking, COPE, and Scottish Highland Games. Plus new activities of Cowboy fast draw, Viking adventure, and Area 51 (to fight off alien invaders). Scouts must be at least 13 years old or a graduate of the seventh grade and must pass the BSA Swimmer's test. Adult participation is very much encouraged. **Without sufficient adult leadership and participation, our Scouts will not be able to attend.**

Cost for the Chisholm Trail High Adventure Camp will be \$360 per person.

You must return this form with your initial deposit by the Jan 12th Troop Meeting to attend Chisholm Trail High Adventure Summer Camp.

We will need to make reservations by specific headcount based on each Pontoon Boat's capacity. Boats range in size from 10 to 15 people. Each boat must have a minimum of two-deep adult leadership at all times.

Availability is first come - first serve, based on the date the Outing Notice is turned in and deposit is made. If we exceed a boat's capacity by a few scouts, but not enough to obtain another boat, those last few scouts will not be able to attend. They will receive a full refund. However, once a headcount is determined and boats procured, there will be no refunds.
